Hereby we confirm that GARLOCK GmbH Neuss does not develop, produce or put into circulation preparations or substances, but does manufacture articles from products which are chemically and thermal neutral. Finished products are designed for their function and are not characterised by their chemical composition.

These products and their packaging contain no materials above 0,1 weight %, which are mentioned according to article 59 (1/10) of regulation (EU) No. 1907/2006 („REACH“) within candidate listing (SVHC List (Substances of Very High Concern) newest issue of 16th January 2020 <https://echa.europa.eu/candidate-list-table>).

GARLOCK GmbH is a "downstream user" in the sense of REACH. Our articles are considered as "Products" and not as "Substances" and therefore are not subject to registration.

Furthermore, we confirm conformity for products of GARLOCK GmbH to EU Guide Line 2003/11/EG, for restriction of allocation and use of specific hazardous materials and compositions (Pentabromdiphenylether, Octabromdiphenylether). All materials are free of these substances, which are to be classified according to EU Guide Line 2003/11/EG as limited:

- 1.) Pentabromdiphenylether (C₁₂H₅Br₅O; CAS.Nr. 32534-81-9)
- 2.) Octabromdiphenylether (C₁₂H₂Br₈O; CAS.Nr. 32536-52-0)

This declaration is also in line with the Directive on the restriction of the use of certain hazardous substances in electrical and electronic equipment 2002/95/EC (RoHS). Our Articles do not contain lead (Pb), Mercury (Hg), Cadmium (Cd), Hexavalent chromium (Cr⁶⁺), Polybrominated biphenyls (PBB), Polybrominated diphenyl ether (PBDE) or further substances mentioned in EC Guide Line (delegated) 2015/863 Annex II.
